**NEW BUSINESS**

**Request for Funding for the July 4, 2018 Independence Day Program**

Mayor Burtner reported that last year the community put together a celebration for the Fourth of July held at Lykins Park. He stated the event started at 5 p.m. years before but not last year. Magistrate Daniel Konstantopoulos was the fireworks coordinator. The City split the total cost for the Fourth of July event last year. Magistrate Konstantopoulos will be the fireworks coordinator this year. The committee is looking to make it a family friendly and children friendly event. The total cost will be \$8,000 and the City would pay half and make a \$4,000 appropriation for this event. The committee is also looking at sponsorships and fundraising for this event.

On motion by Commissioner Cox, seconded by Commissioner Strode, and with unanimous vote, this Ordinance was adopted after second reading. Ordinance No. 5-2018. Joe Barnes, Victor Camp, Julie Kerber, Tracey Miller, and Erica Warland were present and commended the Commission for enacting this ordinance.

Commissioner Beach reported he spoke to Chief Palmer regarding the Department’s ability to cross check and keeping track of those doing the violations.

Commissioner Strode thanked those who shared their concerns and reported that the downtown and the community still needs to continue the work and thanked everyone for their support.

Commissioner Beach requested that the Parks Board make sure there is signage up to make patrons aware of the new hours.

Commissioner Strode requested in the busier times for the parks, that Chief Palmer have extra patrol around the park, including foot and bicycle patrol.
