Ms. Shirley Morton-Willliams, 613 Glenwall Road, Lexington, executor of her father's estate requested assistance with a piece of land-locked property on Spring Street her father owned. She stated the attorney for her father's estate informed her she had to get a clear deed to the property. She is requesting the City investigate this property and contact her with regard to the situation.

Ms. Cynthia Carr, 19 Magnolia Street spoke before the Commission regarding the concerns she and her husband Jeff have with the drug activity in her neighborhood. She stated there are people in the area that are rambling about and trying to break into homes, even with the owners at home. She stated these people have torn down her privacy fence several times and now they are having to expend funds to install cameras and get their fence repaired.

Mayor Burtner requested Sgt. Thompson and Detective Matt Reed, Winchester Police contact the Carrs and step-up foot and vehicle patrol in the area.

Detective Matt Reed provided an update on police activity and patrols in the area.

Mr. Anthony Grisby, 135 Fifth Street requested an update on the planned cul-de-sac on Fifth Street. He stated he still had concerns regarding his neighborhood and the parking situation. He also noted his concerns about dogs running up and down the neighborhood.

As such, they instruct those entities that there are stipulations on when they can use the Canopy or Depot Street due to the Farmers Market having priority.
