APPROVAL OF MINUTES (May 17, 2021 meeting) approved unanimously.

Ms. Cecil, Ms. Layne and Ms. Power- were sworn in.

NEW BUSINESS- None

PUBLIC HEARINGS

111 McCullough Ln- Ken Bradley, County Attorney's Office, presenting the case, was sworn in. This property is an estate property (Connie King) and has never been settled. Dollie Harrison says she has a Bill of Sale for this property. The property has garbage everywhere, tires, and the grass is over 4ft. tall. There have been 7 charges sent to district court about the property but the cases are still pending. Mr. Pritchett made a motion that the owner be told to come to the July 19, 2021 meeting. If they do not attend the meeting the Board will impose a \$500 fine and after that the fine will go to \$100/day. Mr. Fugitt second the motion. Motion passed unanimously.

130 W. Lexington Ave.- Attorney Alex Rowady was at the meeting to represent this property. Mr. Rowady was sworn in. Mr. Rowady said he had been in contact with Mr. Ratliff and Tyler Borders, Realtor. Mr. Rowady had a 6-month contract between Mr. Borders and Mr. Ratliff to sell the property. Mr. Rowady was told to make sure if the property was sold the new owners were aware of the violations. Mr. Fugitt made a motion to table this matter until the August 16, 2021 meeting. Mr. Pritchett second the motion. The motion passed unanimously.

105 E Broadway- Rev. King was at the meeting to represent this property along with Jad Farhat, Wildcat Construction. Both were sworn in. Rev. King said he had talked to several contractors and decided to use Wildcat. The goal of the building is to make it a museum of the history of worship. Mr. Fugitt made a motion that by the September 20, 2021 meeting, The frames of the windows be painted, an 8ft. fence be put up on the parking lot side of the church, the steeple openings be covered, and they have a report from a structural engineer. Mr. Pritchett second the motion. Motion passed unanimously.

112 W. Hickman- No one at the meeting to represent this property. Mr. Long made a motion to table this until the July19, 2021 meeting, awaiting more information. Mr. McCarty second the motion. The motion passed unanimously.

Licensing Board Issues- Dianna Layne to represent the City. 6 companies have not paid for/renewed their business license for 2020 and 2021. Mr. McCarty made a motion to fine all the companies \$100 and if not paid in 30 days the fine will go up to \$100/day. Mr. Pritchett second the motion. Motion passed unanimously.
